

## CITY COUNCIL PROCEEDINGS

June 16, 2021

The City Council of the City of David City, Nebraska, met in open public session in the lower level of the Municipal Auditorium, 699 Kansas Street, David City, Nebraska. The Public had been advised of the special meeting by publication of notice in The Banner Press on June 10<sup>th</sup>, and an affidavit of the publisher is on file in the office of the City Clerk. The Mayor and members of the City Council acknowledged advance notice of the meeting by signing the Agenda which is a part of these minutes. The advance notice to the Public, Mayor, and Council members conveyed the availability of the agenda, which was kept continuously current in the office of the City Clerk and was available for public inspection during regular office hours. No new items were added to the agenda during the twenty-four hours immediately prior to the opening of the Council meeting.

Present for the meeting were: Council members Thomas Kobus, Jessica Miller, Patrick Meysenburg, and Bruce Meysenburg, City Administrator Clayton Keller and City Clerk Tami Comte. Mayor Zavodny and John Vandenberg were absent.

Also present for the meeting were: Library Board President Monica Heller, Library Director Kay Schmid, Park/Auditorium Supervisor Bill Buntgen, and Street Supervisor Chris Kroesing.

The meeting opened with the Pledge of Allegiance.

Council President Tom Kobus informed the public of the "Open Meetings Act" posted on the east wall of the meeting room asked those present to please silence their cell phones.

The Library, Airport, Street department, Recycling, Park, Auditorium, Swimming pool, Schweser House, General, Building Permits, Social Security, Various Purpose, Tax Increment Financing, Sales Tax, Capital Improvement and Ball Program/Recreation budgets were presented by the department heads and City Administrator Clayton Keller.

Council member Jessica Miller made a motion to recess the meeting until June 17, 2021 at 6 p.m. Council member Bruce Meysenburg seconded the motion. Voting AYE: Council members Miller, Pat Meysenburg, Kobus, and Bruce Meysenburg. Voting NAY: None. The motion carried and the meeting was recessed at 8:10 p.m. to June 17, 2021 beginning at 6 p.m. Council member John Vandenberg was absent. Council President Tom Kobus declared the meeting in recess at 8:10 p.m.

Council member Pat Meysenburg made a motion to reconvene the recessed meeting from June 16, 2021. Council member Bruce Meysenburg seconded the motion. Voting AYE: Council members Kobus, Pat Meysenburg, Bruce Meysenburg and Miller. Council member John Vandenberg was absent.

Also present for the meeting were: Mayor Alan Zavodny, City Administrator Clayton Keller, City Clerk Tami Comte, Electric Supervisor Pat Hoeft and Interim Water Supervisor Aaron Gustin.

The Electric Department revenue, Electric system, Electric plant, Water Department revenue, Water system, Sewer Department revenue and Sewer system budgets were presented by the department heads and City Administrator Clayton Keller.

There being no further business to come before the Council, Council member Pat Meysenburg made a motion to adjourn. Council Member Bruce Meysenburg seconded the motion. Voting AYE: Council members Bruce Meysenburg, Pat Meysenburg, Miller and Kobus. Voting NAY: None. Council member Vandenberg was absent. The motion carried and Mayor Zavodny declared the meeting adjourned at 7:56 p.m.
