Donnie Steager representing the Butler County Ag Society introduced himself. Donnie wanted to know if the city annexes the Ag Society if the street that currently goes through the Ag Society would become a city street or if that would stay private since they currently close the gates to the public when they are holding events and auctions.

City Attorney David Levy stated, "If it is not already a city street, it will not become a city street automatically by virtue of the annexation."
