Chairman Jim Masek opened the meeting at 8:00 a.m. in the meeting room of the City Office Building, 557 4th Street, David City, Nebraska, and notified the public of the "Open Meetings Act" posted on the east wall of the meeting room. Chairman Jim Masek also notified the public that if you wish to speak to the Commission to please state your name and address for the record.

Jan Sypal introduced herself and said, "My property, of course, I think everybody knows is next to the proposed change of the future land use map. Up until today, I have never even saw a copy of this plat map that you have in front of you. When we went to the council meeting several months ago our biggest concern, as homeowners in that area, was that we didn't want little bitty lots, which would be less than seventy-five feet. At that time, the City Council, basically told us that was not going to happen. They would guarantee that they wouldn't approve lots less than seventy-five feet. They wanted to put nice homes up there; homes that would be similar to what the area is designed for, and then come to find out, just a couple of weeks ago or a week ago or whatever, that this did get put into small lots. And like I said, today was the first day that I actually saw the plat map. I had stopped at the City Office before, and this was not available. So, we have a huge concern about that; I don't think any of us, I am not going to speak for everybody else sitting by me, I am sure they are going to speak on their behalf, but I think our whole mentality is that none of us have a problem with development in David City, we have no problem with the development behind us, but we do have a problem with what kind of development is behind us and by putting in these small lots. What is interesting to me, being a lifelong citizen to David City, is several years ago David City City Council and Mayor, at that time, decided to go from a fifty-foot lot to a seventy-five-foot lot in David City. It used to be that you could build on a fifty-foot lot in David City. I think Jim probably remembers this; Pam probably remembers this. It used to be that you could build on a fifty-foot lot. When the City Council and Mayor decided that fifty-foot was not sufficient to put up a nice home, it wasn't going to be a good piece of property in the Community, it wasn't going to be resellable and so they changed it so that you have to have a seventy-five foot lot to build in any of the city limits in David City. And so now all of the sudden we are going back, back in time, basically, even though our housing is bigger, our families want bigger homes. Now we are pulling ourselves back to less than seventy-five foot. So, I have a problem with that. Like I said, I don't have a problem with the development, but I do have a problem with the size of the lots."

City Clerk Tami Comte said, "I am not sure where you got your information but in R-2 the minimum lot width is fifty-foot yet. Always has been as far as I know."

Jan Sypal asked, "You mean in the community itself?"

City Clerk Tami Comte said, "Yes, in R-2. So anywhere that is R-2, the minimum lot width is fifty-foot."

Jan Sypal asked, "And how many places in the community are R-2?"

City Clerk Tami Comte said, "Most of them. The map is on the wall."

Jan Sypal asked, "How long has that been?"

City Clerk Tami Comte said, "As long as I can remember."

Jan Sypal asked, "What was this area zoned before?"

City Clerk Tami Comte answered, "R-1."

Jan Sypal asked, "Which requires?"

City Clerk Tami Comte answered, "Ten thousand five hundred square foot lots."

Jan Sypal asked, "Which is?"

Planning Commission member Keith Marvin answered, "Less than a quarter acre."

Linda Vandenberg introduced herself and said, "We also have a property that is in this area. You used our property when you were trying to get your TIF funding before. The last time I was at your meeting, your zoning meeting, we had asked for transparency. I agree with Jan Sypal, we have not seen anything. Today was the first time I saw that. We asked for transparency because we had received no notification. You said we publish it. We said that we are a small community. At the time you were using our properties for your TIF funding for your study, we requested transparency. You guys agreed that you would do that. There were eight properties and you had indicated that you agreed. Mr. Meister was here, and he got it. He said, 'All they are asking for is transparency, give us the information, if you could just share that information of which I haven't gotten anything. First time I saw this. First time I was notified of this was when I saw the yellow sign posted out on the property that it was up for rezoning. So, as far as I am aware I don't know if you have made any attempts to contact us like we had asked, and pretty much you had agreed to. Also, the City Council meeting that we were at the Auditorium, very much the same conversation. The City Council pretty much agreed and promised that they were not going to authorize any lots for any less than seventy feet because they were not going to rezone it to the fifty feet. And here we are, I don't know where that break in communication was, they said in their meeting, it's your due diligence to find those minutes of the meeting where they said that they are not going to rezone it from seventy-five down to fifty feet. Mr. Kobza was at that meeting, he also agreed that you are not going to be able to build anything on a fifty-foot lot with the type of housing you were talking about. We were concerned about low-income housing, and you said no-no it's not low-income housing, so then we called it workforce housing. Well, it's just a play on words. So now it is not called workforce housing and then we called it affordable housing. Now it is no longer called affordable housing because you can't build an affordable house on a seventy-five-foot lot, so now you are trying to reduce it down to fifty. We have changed our verbiage, it's not low-income; it's workforce housing; it's not workforce housing; it's now affordable housing. Your demographics are changing. Your words are changing. In reality we all know that that also means an all-mapped low-income housing. I expressed my concern then, too, when you are bringing in low-income housing; what it does to

the properties in the area. It brings our values down to our properties, that is a concern. I think any of you put in the same spot would be concerned as well with that. One of the appraisers also said that I would definitely be concerned because what comes with it. I am looking at the full spectrum because what comes with low-income housing; your crime rates go up. What does it do to the school district when you are now bringing households into this area that are not going to be contributing but we are now going to be required to educate these kids. We don't have twenty-four-hour law enforcement coverage right now. I am looking at the full spectrum and what kind of impact does that have. Based on this, what kind of housing, I guess, can you give me an answer of what kind of housing are you going to put on here? Is there going to be an income requirement for this type of housing?"

Planning Commission Member Keith Marvin said, "My first question, Linda, is what is your definition of low-income and workforce housing? I will tell you what state has defined it as up to a house that is three hundred and twenty-five thousand dollars in value in construction costs. The houses that were built on 12th Street, all those houses were considered workforce housing. We are not talking slums. We are talking about attractive, good-looking homes. The fifty-foot lot, if the developer can't develop on the lot, they still have the option to purchase a lot and a half. The thought process is one of the biggest costs there is besides the lumber on these homes is infrastructure costs. So, the logic behind smaller lots is you have more frontage, and you have more lots to spread the cost out, instead of, the infrastructure for a hundred-foot lot and dumping that entire cost on that lot, you can now spread that cost on to two lots, which makes it a more affordable lot. It doesn't mean anything about the home itself. By standards there are quality standards that have to be met by the state to qualify as workforce housing. Twelfth Street would meet those standards."

Linda Vandenberg asked, "What are the sizes of those lots?"

Planning Commission Member Pam Kabourek said, "I just looked up two of them and they are eight thousand nine hundred thirteen square foot."

Linda Vandenberg asked, "What is the frontage on them?"

Planning Commission Member Keith Marvin said, "It's an eighty-one-foot lot."

Linda Vandenberg said, "An eighty-one-foot frontage and you want to go to a fifty-foot frontage?"

City Clerk Tami Comte said, "There are no lots on here that are less than sixty."

Jan Sypal said, "I think I seen some on there that are less than sixty."

City Clerk Tami Comte said, "There may be one that is fifty-nine."

Planning Commission Member Keith Marvin said, "There is one that is forty-one twenty but that is only the straight part, that is not the curve that goes onto the street. So, it is about a sixty-foot lot."

Linda Vandenberg added, "So, it's not a hundred-foot lot and making it more affordable so that they can have a fifty-foot lot, but you want to put three seventy- five, but you are saying that they can buy a lot and a half. You're splitting hairs."

Planning Commission Member Keith Marvin said, "Well, it is up to the developer. The city is trying to look at ways to make this affordable for somebody that can come in and buy a lot. If they want a sixty-foot lot because of the cost then they have to find a house that fits into those guidelines and setbacks. There is still going to be standards that are going to have to be met and the key to that is finding the right developer. As you go into Seward from the north all those homes that are up and you can see that are between the cemetery and the school that are right off of that, some of them connect from the highway and some of them don't. All of those were done by the same developer that did 12th Street and those are all considered workforce housing."

Discussion continued.

Planning Commission Member Keith Marvin commented, "What he is comparing is the fact that we came in and built low-income housing in the nineties and it's still not a slum today. One of the reasons that I moved to this town thirty some years ago is because I like the character of this town. The people of this town, for the most part, take care of their properties, they respect homeownership. I think that is important. You buy a house that has two hundred and fifty to three hundred thousand dollars of value in it, I would hope that they are not going to let it run down."

Jan Sypal added, "But if you are talking affordable housing, you are not going to be talking something like that because affordable. If you go to the state website...."

Alyssa Ledon introduced herself and said, "So, you had defined what, or quoted what low-income housing allegedly was according to the State of Nebraska."

Planning Commission Member Keith Marvin said, "It's not low-income, it's called Workforce. "

Alyssa Ledon continued, "Low-Income is designed as having a household income that is sixty percent or less of the area median gross income adjusted for household size. For example, to qualify as low income for a household of four income would be forty-eight thousand two hundred forty-eight dollars or less. I don't know where you got your definition but that comes from the State of Nebraska website."

Planning Commission Member Keith Marvin said, "That definition is out of the state with regard to workforce housing and what qualifies for special funding under the workforce housing act."

Planning Commission Alternate Brian Small said, "Where are you reading? Workforce or low-income?"

Alyssa Ledon answered, "Low income because that is what you were saying."

Planning Commission Alternate Brian Small said, "That's not the same thing."

Bradlee Carls introduced himself and said, "That is literally what you were calling it five seconds ago."

Planning Commission Member Keith Marvin said, "No, that is what you guys were calling it."

Bradlee Carls continued, "To give you an idea, I have a pergola built out in my back yard that is fifty by forty-five. The pergola itself, the footprint for my pergola, is fifty by forty-five. You want to build houses as big as my pergola in my back yard, or behind us."

Alyssa Ledon said, "So I have a question, my biggest question is that I haven't seen this map or whatever because obviously no one wanted to show us anything with this development, but my question would be is how many houses are we foreseeing being put on this new map? And then obviously I know that there is discretion because of the developer could ask for a lot and a half or whatever, but regardless of what are we looking at as far as how many houses back there."

Chairman Jim Masek said, "Skip, you kind of know this, right?"

Special Projects Coordinator Dana Trowbridge said, "About thirty-six lots."

Alyssa Ledon said, "The second question is how are we accessing that? Where is this roadway going? Where is this happening?"

Planning Commission member Keith Marvin said, "If you look at it, it's coming off of "O" Street to the north and there will be a road that will be built back to the highway. It's a secondary and it is going to have a stub out to go north."

Bradlee Carls asked, "How are you going to get the footage to fit a road through there without condemning me or their land?"

Planning Commission member Keith Marvin said, "We are going to do it as a sixty-foot right-of-way."

Bradlee Carls said, "Isn't that like fifty-five feet right now?"

City Clerk Tami Comte said, "I believe Brian Foral said it was sixty."

Chairman Jim Masek said, "Well according to the map it is 60.02 feet."

Discussion continued.

Planning Commission member Keith Marvin said, "As far as notices, the city staff did exactly what we are required to do by law. We posted the property. Linda that is exactly what we are supposed to because you apparently saw the yellow sign. We are not required to send it to everybody that is involved because if you miss somebody then you are in trouble."

Linda Vandenberg said, "I agree. And that is what we asked as the last meeting is if we could have some transparency."

Discussion continued.

Special Projects Coordinator Dana Trowbridge said, "Never has the term income requirement been used as we have talked about this development. Income Requirement does not have anything to do with Workforce Housing. The definition of workforce housing does not use those terms. There is nothing going on up there that is income limited or income measured. Nothing. So, I don't know where you are coming up with these fantasies about income requirements. They don't exist."

Alyssa Ledon said, "It was used on previous developments similar to this development so they can use it as comparison."

Special Projects Coordinator Dana Trowbridge said, "We are not talking about previous developments at this meeting."

Planning Commission member Keith Marvin said, "Okay, what I was doing was I was comparing the style of construction that was built on 12th Street. How Matt Thomas developed 12th Street had funding requirements that actually require income-based applications. To my knowledge the city hasn't been looking at those types of funding mechanisms to do this."

Alyssa Ledon said, "Okay, that is what we are asking."

Discussion continued.

Planning Commission member Keith Marvin said, "With this process, like I said, in order for the city to start finalizing some discussion with people that want to take on this project, we have to have at least something that is on a preliminary plat level. The city has all the authority in the world once we go to final plat to establish covenants. We can dictate some certain design standards and different things like that with regard to how things are developed. Now, has that been developed yet? I don't think so, it's not that point in time."

Linda Vandenberg added, "That is where we get concerned. We have been told this before, 'We're not at that point in time, we're not at that point in.' Then you are and we never get notified that it's there and then the next time we hear it's already beyond that. Last time we were here at this meeting we are not at this point, this is just a preliminary stage is what you guys told us and then all of the sudden bam here we are."

Planning Commission member Keith Marvin said, "All this is is a rezoning for a preliminary plat. That is all this is."

Jan Sypal said, "Then why don't you have a preliminary plat with seventy-five-foot lots?"

Linda Vandenberg said, "Who requested you to go from seventy-five to fifty?"

Planning Commission member Keith Marvin said, "This was done at the CDA's (Community Development Agency) direction, and we were presented a plat. I do not recall the conversation, if the council members actually said that then the true test will be when this comes to them next week to hold their feet to the fire to the seventy-five feet. If that is truly what they said. What we are going to act on is does this meet the requirements for rezoning and changing the land use and meet our preliminary plat requirements."

Jan Sypal said, "You, as a Planning Commission, have control. I mean you have control. You have control to forward this to the council."

Planning Commission member Keith Marvin replied, "We are only a recommending body."

Chairman Jim Masek said, "We can only recommend it to the council. It is up to the council to decide."

Jan Sypal said, "That is what I am saying. You have that authority. That is your commission is to recommend it to the council."

Chairman Jim Masek said, "The council can change it. If they do not like what we are recommending, they will change it."

Planning Commission Alternate Brian Small said, "I like it. I would recommend this."

Discussion continued.
