

CITY COUNCIL PROCEEDINGS

January 9, 2023

The City Council of the City of David City, Nebraska, met in a joint open public session with the Butler County Board of Supervisors in the meeting room of the City Office, 490 "E" Street, David City, Nebraska. The Public had been advised of the meeting by publication of notice in The Banner Press on December 29th and an affidavit of the publisher is on file in the office of the City Clerk. The Mayor and members of the City Council acknowledged advance notice of the meeting by signing the Agenda which is a part of these minutes. The advance notice to the Public, Mayor, and Council members conveyed the availability of the agenda, which was kept continuously current in the office of the City Clerk and was available for public inspection on the City's website. No new items were added to the agenda during the twenty-four hours immediately prior to the opening of the Council meeting.

Present for the meeting were: Mayor Jessica Miller, Council President Bruce Meysenburg, Council members Tom Kobus, Jessica Miller, Kevin Woita, Keith Marvin and Pat Meysenburg, City Attorney David Levy, and City Clerk Tami Comte. A vacancy exists for a Ward 1 Council member.

Also present were: County Board members Scott Steager, Tony Krafka, Scot Bauer, Jan Sypal, Robert Coufal, Ryan Svoboda, Anthony Whitmore, Sheriff Tom Dion, Butler County Attorney Julie Reiter and County Clerk Stephanie Laska. David City Street Supervisor Chris Kroesing and Butler County Roads Superintendent Randy Isham were also present.

The meeting opened with the Pledge of Allegiance. Mayor Miller notified the public of the "Open Meetings Act" and asked those present to silence their cell phones. She also reminded the public that if they speak tonight in front of the Council that they must state their name and address for the record.

Street Supervisor Chris Kroesing stated that the City needs help with grading the roads.

Butler County Roads Superintendent Randy Isham stated that if the County were to enter into an agreement with the City he would want the fee based on an hourly basis and not per mile. He used the FEMA rate and averaged the motor grader employee salaries and came up with approximately \$161.04 per mile.

After discussion it was determined that the County would put together an interlocal agreement and try to have it for their meeting on January 17th.

Council member Kevin Woita made a motion to table the action concerning an interlocal agreement regarding road maintenance. Council Member Pat Meysenburg seconded the motion. The motion carried.
