This tower would host the law enforcement and fire department radio repeaters. Scott and Butler County have been in contact with the State of Nebraska and FAA for a site and have received approval of this location. They will have illumination on the tower. The County will be using ARPA funds to pay for the tower. Equipment will be paid for by the entities that will be using the tower to host repeaters.


